

DIRECT INVESTMENT PROGRAMS

The *Direct Investments Spectrum* newsletter covers the investment arena consisting of nonlisted real estate investment trusts (REITs), limited partnerships, limited liability companies (LLCs) and other direct investment programs. While these programs are publicly-held and therefore registered with the Securities and Exchange Commission, they are not listed for trading on any recognized securities exchange.

The list below is representative of the direct investment programs that are on the radar screen of the *Direct Investments Spectrum*. The ten-digit Central Index Key (CIK) number assigned by the S.E.C. for each of these programs is provided below.
